

WARRANTY FOR NEW JOHN DEERE TURF & UTILITY EQUIPMENT (Canada Only)



- A. GENERAL PROVISIONS** - The warranty described below is provided by John Deere Canada ULC, 295 Hunter Road, P.O. Box 1000, Grimsby, Ontario, L3M 4H5 ("John Deere") to the original purchaser of new Turf & Utility Equipment ("Equipment") purchased from John Deere or authorized John Deere dealers. Under this warranty, John Deere will repair or replace, at its option, any part covered under this warranty which is found to be defective in material or workmanship during the applicable warranty term. Warranty service must be performed by a dealer or sales service centre authorized by John Deere to sell and/or service the Equipment (the "authorized dealer"). The authorized dealer will use only new or remanufactured parts or components furnished or approved by John Deere. Warranty service will be performed without charge to the purchaser for parts and/or labour. However, the purchaser will be responsible for service calls and/or transportation of Equipment to and from the authorized dealer's place of business (except where prohibited by law), for any premium charged for overtime labour requested by the purchaser and for any service and/or maintenance not directly related to any defect covered under this warranty. This warranty is transferable, provided an authorized dealer is notified of the ownership change, and John Deere approves the transfer.
- B. WHAT IS WARRANTED** - Subject to paragraph C, all parts of any Equipment are warranted for the number of months or operating hours specified below. Warranty statements covering engine emission-related parts and components, which shall not be less than the engine warranty, are found in the Operator's Manual delivered with the Equipment. **Only the following Compact Utility Tractor components are covered by the Compact Utility Tractor Powertrain Warranty:** (i) **Engine:** cylinder block, cylinder head, valve covers, oil pan, timing gear covers, flywheel housing, emissions control components and all parts contained therein and, (ii) **Powertrain:** transmission, transmission case, differential and axle housings, clutch housings, MFWD front axle assembly, and all parts contained therein (does not include external drivelines, dry clutch parts, or steering cylinders).
- C. WHAT IS NOT WARRANTED** - Pursuant to the terms of this warranty, **JOHN DEERE IS NOT RESPONSIBLE FOR THE FOLLOWING:** (1) Used Equipment (unless it is specifically covered by separate warranty documents); (2) Any Equipment that has been altered or modified in ways not approved by John Deere, including, but not limited to, setting injection pump fuel delivery above John Deere specifications; (3) Depreciation or damage caused by normal wear, lack of reasonable and proper maintenance, failure to follow operating instructions, misuse, lack of proper protection during storage, vandalism, the elements or collision or accident; (4) The Utility Vehicle if used for racing or any other competitive activity; (5) Normal maintenance parts and/or service; (6) Batteries, tires, and John Deere Golf & Turf equipment are warranted under separate warranty.
- D. SECURING WARRANTY SERVICE** - To secure warranty service the purchaser must, (1) Report the Equipment defect to an authorized dealer and request warranty service within the applicable warranty term; (2) Present evidence of the warranty start date together with the valid proof of purchase; and (3) Make the Equipment available to an authorized dealer or service centre within a reasonable period of time.
- E. NO IMPLIED WARRANTY, REPRESENTATION OR CONDITION** - To the extent permitted by law, neither John Deere nor any company affiliated with it makes any warranty, representation, condition or promise, express or implied, verbal or otherwise, as to the quality, performance or freedom from defect of the Equipment. **NO IMPLIED OR STATUTORY CONDITIONS OR WARRANTIES OF MERCHANTABILITY OR FITNESS (WHETHER PURSUANT TO THE SALE OF GOODS ACT OR ANY OTHER STATUTE OF ANY PROVINCE OR OTHERWISE) ARE MADE.**
- F. EXCLUSIVE REMEDY** - To the extent permitted by law, the purchaser's exclusive remedy in connection with the breach or performance of any warranty on the Equipment are those set forth in this warranty. **IN NO EVENT WILL AN AUTHORIZED DEALER, JOHN DEERE OR ANY COMPANY AFFILIATED WITH JOHN DEERE, BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES OR INJURIES, INCLUDING BUT NOT LIMITED TO, LOSS OF PROFITS, RENTAL OF SUBSTITUTE EQUIPMENT, OTHER COMMERCIAL OR PERSONAL LOSS OR DAMAGES ARISING AS A RESULT OF A FUNDAMENTAL BREACH OR BREACH OF A FUNDAMENTAL TERM.**
- G. NO DEALER WARRANTY** - Except for conditions or warranties which may not be excluded by law, the selling authorized dealer makes no warranty of its own on any item warranted by John Deere, and makes no warranty on other items unless it delivers to the purchaser a separate written warranty document specifically warranting the item. **THE SELLING AUTHORIZED DEALER HAS NO AUTHORITY TO MAKE ANY REPRESENTATION OR PROMISE ON BEHALF OF JOHN DEERE OR TO MODIFY THE TERMS OR LIMITATIONS OF THIS WARRANTY IN ANY WAY.**
